

1. That, I and my family members, are victims of present current that occurred from 8-5-23 onwards. We are staying at Kumam Leikai relief centre Moirang at present.
 2. That, the unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves destroyed my household properties and burnt our house, not only this they attacked me with guns, threatening my life, Luckily the bullet missed me, But now I am in mental trauma fearing life.
 3. Delay of filing of F.I.R is due to displacement and uncertainty of relief camp/place.
- In view of the facts and circumstances. I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them as punish them in accordance with law.
