Sir,

Me and my family members are victims of the present unrest that occurred from 03-05-23. Presently, I am taking refuge at morning Kumam Leikai Relief Camp. along with my family.

The unknown armed miscreants suspected to be of kuki tribe as they were using kuki dialects among themselves attacked us with guns and stones. We encouraging among themselves to take our life. We ran away from them but while running I was hit by stone on my back causing serious injury to me.

Delay in filing an FIR is due to displacement, injuries and uncertainty of relief camp.

Therefore, in view of the facts and circumstances mentioned above, I shall be grateful if you kindly take up necessary actions to apprehend and punish the armed miscreants in accordance with the law.


