with due respect, I, the undersigned
namely N. IBEMCHA aged about 25 years, resident
of KHAMUSAMBA MEITEI LEIKAI, CCPUR beg to
submit the following few lines for your kind
consideration and necessary action.

That, on 04/05/2023 at about 11:30am while I was
at home along with my family members consisting
of myself, my husband / wife, children and
other family members, some unknown armed
miscreants attacked my house, physically assaulted
my family members including myself and destroyed
household properties worth around RS 3,06,000/-
(Rupees Three lakh six thousand only approximately).
That, the unknown miscreants are suspected to be
of the Kuki tribe as they conversed among
themselves in the Kuki dialect while physically
assaulting my family and destroying my household
properties. The said unknown armed miscreants
also set on fire and burned down my residential
house, ~~more~~ or non private vehicle and other

List enclosed along with this report.

That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of FIR is due to displacement and uncertainty of relief camp.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehend them and punish them in accordance with law.


