I, the undersigned namely Naorem Bheigha Sing
S/o(L) N. Bidhu Singh of Khumujamba Meitui Leika
Churachandpur, beg to submit the following
report and request to register a FIR.

That, on 04/05/2023 at about 1145 AM, a large
group of armed kuki group, numbering
more than a thousand attacked Khumujamba
Meitui Leikai and started firing from sophisticated
weapons. The kuki group simultaneously torched
and burnt the houses of the above mentioned
village. I along with my family members
fled and took refuge in a nearby Assam
Rifle camp. I and my family members
were unhurt. The kuki group looted all
household items from inside ^{my} the house
and my house was completely burnt

That, I and my family members are presently taking shelter in a relief camp at Moirang.

A separate sheet listing the lost and stolen/looted items is attached with the report.

That, the delay in filing FIR is due to the prevailing tense and volatile situation and uncertain condition of staying in relief camp.

That, the above report is submitted for initiation of necessary action, subsequent registering of FIR, book the culprits involved and responsible for and on the incident and take strict action against them as per the law of the land.
