Subject: Report on losses and for registering
an FIR.

Sir,

With due respect, I, the undersigned namely SALAM SHANTA SINGH S/O, (Late) SALAM TOMCHOU SINGH, aged about 48 years, a resident of Khumujamba Meitei Leikai, Churachandpur, Manipur-795128, beg to submit the following few lines for your kind consideration and necessary action.

That, on 04/05/2023 at around 11:30 am, some unknown armed persons numbering in thousand attacked my family while I was at home along with my family members, including myself, my wife, children and other family members. Such unknown armed miscreants attacked my house, household properties and completely burned down all my properties worth around Rs. 1700000/- (Seventeen Lakhs) approximately.

That the unknown miscreants are suspected to be of the KUKI Tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties and burnt to ashes,

which are given in the list enclosed along with this report.

That, the unknown armed miscreants warned threatened my family members and myself to leave the village/Leikai permanently and that we will face dire consequences if we return to our village/Leikai again. Delay of filling FIR is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps to identifying the unknown armed miscreants, apprehend them and punish them in accordance with law and take up an FIR against them.
