Respected Sir,

I, the undersigned, beg to report the
following for your kind necessary action.

That, I and my family members are permanent
residents of KHUMUJAMBA MEITEI LEIKAI, CHURACHANDPUR,
MANIPUR-795128 and we are victims of the present
unrest that occurred from 03-05-2023 onwards in
Manipur state.

That on 04-05-2023, at about 11:30 AM, heavily
armed group of Kuki community, numbering in
thousands started attacking the residents of the
above mentioned village by firing from sophisticated
weapons and simultaneously torching houses. We
barely managed to escape with our lives to a nearby
Assam Rifle camp. The armed kuki group looted all my
household items/personal belongings including that of
all family members in the house and completely
burnt my RCC pucca house along with whatever
items left.

That, the total loss is estimated to be approximately ₹ 60,00,000/- (Rupees sixty lakhs) only.

A separate list of some of the main household items looted, stolen and burnt in the above incident is enclosed with this report.

That, I and my family members were unhurt during the above mentioned incident.

That, after a few days, I and my family members were shifted to a relief camp in Moirang and we are presently sheltered in this relief camp.

That, the delay in filing FIR is due to the displacement, shock and trauma experienced and the uncertainty of relief camp. Also, in view of the prevailing and ongoing highly tense and unpredictable situation, it is impossible for me to lodge FIR on the incident to PS Churachandpur.

In view of the above facts and circumstances, it is requested to initiate appropriate steps for taking suitable action against all those involved in accordance with law. A receipt of this report be provided for my use please.
