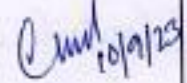

I, the undersigned, beg to report as per under,
for necessary action.

That I and my family members are permanent
residents of Khumujamba Meitei Leikai, Churachandpur
district, Manipur - 795128 and we are victims
of the present unrest situation in the state
that erupted on 03-05-2023 in Manipur.

That on 04-05-2023 at about 11-30 AM, heavily armed
group of Kuki Community, numbering in thousands,
attacked the residents of Khumujamba Meitei Leikai,
Churachandpur by firing from sophisticated weapons
and simultaneously torching houses in the above
mentioned village. The above Kuki group looted all
my household items / belongings and also dumped
construction materials and completely burnt down
my house.

That, I was not hurt in the above incident.
My family members are also unhurt.

That the total loss is estimated to be approximately ₹ 10,00,000/- (Rupees ten lakhs) only. A separate sheet listing the major looted items, stolen ones and those burnt in the above incident is enclosed with this report.

That, I am presently taking shelter along with my family members at Thangjing Sindam Shanglen Relief Camp, Moirang.

That, the delay in filing FIR is due to the displacement, the shock being endured and the uncertainty of relief camp. Also, in view of the highly tense, volatile and unpredictable prevailing situation, it is impossible for me to lodge FIR on the incident at PS Chuachandpur.

In view of the above facts and circumstances, the above report is submitted with request to initiate immediate appropriate steps for taking suitable action against those involved in the above incident.

A receipt of this report be provided for necessary action.

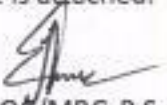
