I, the undersigned beg to report for your kind
and necessary action.

I. That, I and my family members are victims of the
present unrest that occurred from 03-05-2023
onwards.

II. That, on 4/5/23, at about 7:00 pm, some unknown
person numbering about 900 belonging to kuki
community started attacking the undersigned along
with my wife, children and other family members.
Some unknown armed miscreants attacked my house,
physically assaulted my family members including myself
and destroyed household properties worth around Rs.
8,50,000 (Eight lakhs Fifty thousand).

III. That, the unknown miscreants are suspected
to be of the kuki tribe.

ing themselves in the kuki dialect while physically
saulting my family and destroying my household
properties. The said unknown armed miscreants also set
on fire and burned down my residential house
none private vehicle and other household items which
are given in the list enclosed along with this report

IV That, the unknown armed miscreants warned and
threatened my family members and myself to leave
the village permanently and that we will face dire
consequences if we return to our village again. Delay
of filling FIR is due to displacement and uncertain
ity of relief camp. In view of the facts and circum
stances, I shall be very grateful if your good self would
kindly initiate appropriate steps for identifying the
unknown arms miscreants apprehend them and
punish them in accordance with law.

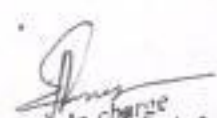
