resident of KHUMUJAMBA MEEITEI LEIKAI CC Pur
beg to submit the following few lines for your
kind consideration and necessary action.

That on 4/5/2023 at about 11:40 A.M

Some unknown persons numbering about 300
belonging to Kuki community started attacking me
undersigned with family members including myself
and destroyed household properties worth around
RS. 21,04,750/- (Rupees Twenty one lakh Four thousand
Seven hundred fifty) approximately.

That, the unknown armed miscreants warned and
threatened my family members and myself to leave the
village permanently and that we will face dire
consequences if we return to our village again.

Delay of FIR is due to displacement and
uncertainty of relief camp/place. In view of the
facts and circumstances, I shall be very grateful
if yourself would kindly initiate appropriate steps

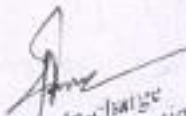
for identifying the unknown among miscreants, approach them and punish them in accordance with law.

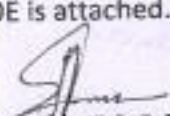
