Sir,
I, the undersigned beg to report for your kind and necessary action.

that I and my family are victims of the present unrest that occurred from 3rd of May 2023 onwards.

That on 4th May at around 7:10 pm, some unknown armed miscreants attacked my family, physically assaulted us and destroyed household properties worth around ₹ 2,00,000 (Two lakhs) approx.

The unknown armed miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting us. They also set my residential house on fire and other household items which are enclosed along with this report.

The unknown armed miscreants also warned and threatened us to leave the village permanently and that we would face dire consequences if we return back.

Delay in filing an FIR is due to displacement and uncertainty of Relief Camp.

I therefore kindly request to take up necessary actions to apprehend the miscreants and punish them in accordance with the law.


