The unknown armed miscreants suspected to be of the kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting us. They also set my residential chouse on fire and other household items which are enclosed along with this seport.

The unknown armed miscreanter also warned and - threatened is to leave two village permanently and that we would face dire consequences if we return back.
