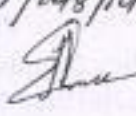

I, the undersigned beg to report for your kind and necessary action.

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

That on 3rd May at around 7:30 p.m. while I was at home along with my family. Some unknown armed miscreants attacked my house, physically assaulted me and my family members and destroyed household properties worth around ₹ 10,00,000/- (Ten lakhs only) approx.

That the unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while assaulting us. The said unknown armed miscreants also set on fire and burned down my residential house, 1 sofa and other household items which are given in the list enclosed along with this report.

That the unknown armed miscreants warned and threatened me and my family to leave the village permanently and that we will face dire consequences if ever return to our village again.

Delay of filing an F.I.R. is due to displacement and uncertainty of relief camp.

In view of the facts and circumstances, I shall be grateful if you would kindly initiate appropriate steps and take up actions to identify and apprehend the miscreants.
