I, the undersigned beg to report for your kind
and necessary action.

1. That I and my family members are victims of
present unrest that occurred from 03-05-2023 onwards.
2. That, on 04-05-2023 at around 7.30 p.m. while
I was at Yenshambam Ramsingh Mitie aged above
70 years at Churachandpur New Bazar Bus Parkin
P.O. Churachandpur P.S. Churachandpur, Churachandpur
District, Manipur. Some unknown persons numbering
about 30 belonging to Kuki community started
attacking the undersigned along with family members.
Thereafter, the Kuki people started destroying the house
and shop of the undersigned resulting in all the property
of the undersigned were razed to the ground and all the
belongings and jewellery were also destroyed.
3. That, the unknown miscreants are suspected to be
of the Kuki tribe as they conversed among themselves
in the Kuki dialect while physically assaulting my family
and destroying my household properties. The said
unknown armed miscreants also set on damage my
residential house, and my pulsor private vehicle.

and other household items which are given in the list enclosed along with this report. Delay of filing FIR is due to displacement and uncertainty of relief camp and staying place.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Kukiz community involved in the damaging my properties ~~about~~ ^{about} Rs 3 lakhs. and take up an FIR against them as soon as possible for the interest of justice.
