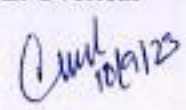

Sir,

I, the undersigned beg to report for your kind and necessary action that, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

That, on 4th May around 8:20 pm while I was at home with my wife and children, some unknown armed miscreants attacked us and started physically assaulting us, destroying household properties worth around ₹ 15,00,000/- (Fifteen lakhs) approx.

That, the unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while assaulting us. The said unknown armed miscreants also set on fire and burned down my residential house, an autorickshaw and other valuable household items enclosed along with this report.

That, the unknown armed miscreants warned and threatened us to leave the village permanently and that we would face dire consequences if we return to our village again.

Delay in filing an F.I.R. is due to displacement and uncertainty of relief camp.

In view of the facts and circumstances, I kindly request to take up necessary steps to identify and apprehend the unknown armed miscreants and punish them in accordance with law.
