1. The undersigned beg to report for your kind and necessary action
1. That, I and my family member are victims of the present arrest the
occurred from 05-05-2023 onwards.
2. That, on 2nd May at around 12:30pm while I was at home along with
my family members consisting of myself, my husband/wife children
and other family members, some unknown armed miscreants
attacked my house, physically assaulted my family members
including myself and destroyed house hold properties worth about
(Rs. 800000. Eight lakhs only) approximately.

3. That, the unknown miscreants are suspected to be of the Kuki
tribe as they conversed among themselves in the Kuki dialect
while physically assaulting my family and destroying my house
hold properties. The said unknown armed miscreants also
set on fire and burned down my residential house, other
house hold items which are given in the list enclosed along
this report.

4. That, the unknown armed miscreants warned and threatened my
family members and myself to leave the village permanently and
that we will face dire consequences if we return to our village.
Delay of fixing a F.I.R is due to displacement and uncertainty
of relief camp place.

In view of the facts and circumstances, I shall be very grateful
if your good self would kindly initiate appropriate steps for
identifying the unknown arms miscreants, apprehend them
punish them in accordance with law.


