Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 on wards.

That on 03-05-2023 around 7:30pm. while I was at home with my wife and children. Some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth Rs. 826,000 - (Eight Laks twenty six thousand) approximately. of

That, the unknown miscreants are suspected to be of the Kukli tribe as they conversed among themselves in the Kukli dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house. One 4-wheeler vehicle (Regn. No. MN04P-0224) and a Scooty Dio (Regn. No. MN02A-6666) along with other household items which are enclosed along with the report.

The unknown miscreants warned and threatened me and my family to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing an F.I.R is due to displacement and uncertainty of relief camp. In view of the facts and circumstances, I shall be very grateful if your goodness would kindly initiate appropriate steps for identifying the unknown arm miscreants, apprehend them and punish them in accordance with law.


