Subject :- Report against Cattle lifting ( stealing of cows).

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Paominthang Guite** aged about 36 years S/o (L) **Lamthang Guite** Belonging to the Any- Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **G Mongjang Churachandpur District Manipur. P.O/P.S., Churachandpur.**
2. That at about **4:30 pm** on the **3<sup>rd</sup> May 2023**, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun and a mob attacked Kangvai Village which is in close proximity from our village. so in order to save our lives we left behind our house with all our belongings including all our domesticated animals and in the process they have stolen our cattle (Five Cows).
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 2,50,000/- ( Rupees Two Lakhs fifty Thousand ) only**
4. Fortunately, I managed to escaped from our village with my family, and now currently taking refuge at **TuitengJang Village Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
