Sir,

With due respect I, T.Sangmuanding age about 20 years S/O T.Thanggoulal a resident of Vengnuam, New Lamka P.O. New Lamka P.S. Churachandpur, Manipur would like to report that because of the ongoing communal war between the Meitei and Kuki Zo Community I along with my friend while visiting Kangvai area on the 27th July 2023 at around 6:00pm Meitei militant armed with sophisticated rifle started firing indiscriminately toward Kangvai Village P.O & P.S Churachandpur with the intention of killing everybody present at the Village as such I was hit by bullet, piercing through both my ankle which left me cripple on the spot.

That, I am evacuated from that area in an Ambulance by some of my friend for which I am hospitalized and unable to give report of my injury on time.

I therefore, request your kind office to take necessary action at the earliest for the end of Justice.
