Subject :- Report on destruction and burning of my house  
situated at Khuga Tampak Zenhang Lamka under  
Churachandpur Police Station.

Application includes request for intimation of Churachandpur Police  
Station for information and necessary action.

Sir,

I have the honour to report that my house at the village stated in the subject had been destroyed and subsequently burnt down by a group of unknown armed miscreants on 04/05/23 at about 9:00am. I and my family members left the area running for our lives only with the clothes we were wearing at the time of the unfortunate incident in the morning about 6:00am under the escort of the Assam Rifles Personnel. All other things including cash and ornaments were left behind in the house.

We have been further moved to Relief Camps within Bishnupur District under armed escort. We are still in the Relief Camp at the time of filing this application. Date and time of the burning of my house has been intimated by a neighbor through phone while I was in the Assam Rifles Camp at Tuibong. Hence this report to your good office.


I would, therefore, request you kindly to allow me to join the Investigating Team at the time of spot enquiry, and thereafter, the detail of the losses may be assessed and reported to you.
