situated at Khuga Tampak Zenhang Lamka under  
Churachandpur Police Station.

Sir,

I have the honour to report that my residential bungalow with other houses within the village constructed on separate patta lands and rented out to different tenants as given below had been destroyed, looted and burnt down by groups of unknown armed miscreants on 04/05/23 at about 9:00am. and thereafter.

List of houses destroyed and burnt down are as follows.

I would, therefore, request you kindly to take up necessary actions for arresting the culprits and recover the loses under intimation and in liaise with the OC, CCPur Police Station within whose jurisdiction the incidents had occurred. Delay in filing this report may kindly be condoned as I and the whole villages have been shifted out to Assam Rifle camps at the time of occurrence of the incidence.


