

I have the honour to report that my residential bungalow with adjoining out-house occupied by a NACO Agency on lease along with other out-houses on separate patta lands occupied by different tenants on rent as given below had been destroyed and looted by groups of unknown armed miscreants on 04/05/23 at about 9:00am, and subsequently burnt down at around 10.pm night.

List of my houses destroyed and burnt down are as follows.
