With due respect, I the undersigned namely **Ngangom Kuber Singh** aged about 40 years, resident of **Tronglaobi Awang Leikai**, Moirang, Bishnupur District beg to submit the following few lines for your kind consideration and necessary action for the reason mention below that my Courier and Cargo Service name as **NG ENTERPRISES ( UKB LOGISTICS Churachanpur District Branch )** located at **Churachanpur New Bazaar** had been looted/robbed/destroyed/burned including its furniture, PC, Laptop, Printer, CCTV camera and other properties of this courier services, on 4<sup>th</sup> & 5<sup>th</sup> May, 2023 by some unknown Kuki community people, no fewer then 300 persons. At around 9 Am

In the above facts and circumstances, I therefore requested you to kindly make a serious enquiry about this matter and help me in getting justice by filling an FIR against unknown Kuki people at the earliest possible.

Your quick action will be highly appreciated. For which acts of kindness I shall ever remain thankfully to you forever.


