With due regards, I have the honour to state that I am a resident of Mandop Leikai, Churachandpur and staying there for the last 20 years or so. And, in the crisis between Meitel and Kuki communities, 2(two) vehicles i.e. Maruti Suzuki XL6 Alpha bearing Regd. No. MN01AS4473 which belongs to me has been destroyed completely and one Honda Activa 6G, Regn. No. Nil (applied for) has been set on fire by some unknown persons from Kuki communities at Zenhang Lamka, Chrurachandpur on the 4th May, 2023 at about 7.30 am when my family and me were trying to leave the place for another safer place.

We were rescued by Armed Security Personnel and took shelter to a relief camp at Churachandpur for few days. Then, evacuated to Bishnupur District and presently taking shelter at a Relief Camp at Phubala.

It is, therefore, requested to kindly register an FIR case in your Police Station regarding the said incident please. Delay on reporting is due to the displacement of home and other issues.
