Subject: Report regarding mischief by fire to my Vehicles at Churachandpur

Sir,

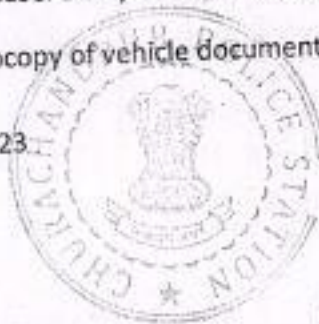
With due regards, I have the honour to state that I am a resident of Mandop Leikai, Churachandpur and staying there for the last 20 years or so. And, in the recent crisis between Meitei and Kuki communities, 3(three) vehicles i.e. Mahindra Thar which belongs to me bearing Regn. No. MN01AW8854 whose Regn. No. was not pasted on the vehicle's Number plate those days have been destroyed completely, while one Maruti Breeza, Regn. No. MN04P0308 and one Honda Activa 6G, Regn. No. MN06SG4712 have been set on fire by some unknown persons from Kuki communities at Mandop Leikai, Churachandpur on the 4th May, 2023 at about 8.00 am when my family and me were trying to leave the place for another safer place.

We were rescued by Armed Security Personnel and took shelter to a relief camp at Churachandpur for few days. Then, evacuated to Bishnupur District and presently taking shelter at a Relief Camp at Phubala.

It is, therefore, requested to kindly register an FIR case in your Police Station regarding the said incident please. Delay on reporting is due to the displacement of home and other issues.
