Sir, I the undersigned beg to report for your kind and necessary action.

1. That I and my family members are victims of present unrest that occurred from 03-05-2023 onwards. We are staying at Kuman Leikai relief camp centre Moirang at present.
2. That, the unknown miscreants suspected to be of the Kuki tribe as they conversed among themselves destroyed my household properties and burned our house. Not only this they attack me with guns threatening my life. Luckily the bullet missed me. But now I am in mental trauma fearing life.
3. Delay of filling of F.I.R is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
