I, the undersigned have the honour to state that large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Suspected Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur on 3<sup>rd</sup> day of May 2023 at around 5.30 pm. The said unidentified groups vandalised my Clinic and looted all valuable items.

In that unfortunate incident, I have lost a total amount of Rs. 26, 96,000/- (Rupees Twenty Six Lakhs Ninety Six Thousand) only after the said unfortunate incident/mob violent.

It is therefore, request you to process for recover my heart earned assets and take necessary legal actions against the accused persons involved, as per law of the land at the earliest.

I shall be grateful for your kind co-operation and necessary actions.



