Sir,

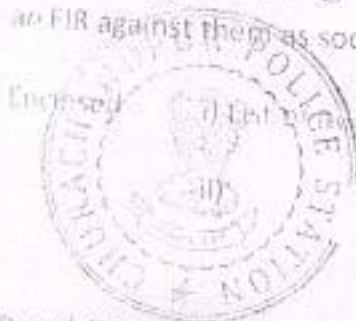
With due respect, I, the undersigned namely Laishram Bijen Singh aged about 32 years, resident of Ngathal Meitei Leikai beg to submit the following few lines for your kind consideration and necessary action.

That on 03-05-2023 at about 7:30 Pm, some unknown persons number about 300 belonging to Kuki community started attacking the undersigned along with fan members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all belongings and jewellery were also burned/destroyed / stolen before burning/ damage.

In the said incident I was badly injured due to pelting stones/hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached also with the present application.

In the above facts and circumstances, it is therefore respectfully requested that you goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/ damaging my properties and injuring me and take an FIR against them as soon as possible for the interest of justice.
