With due respect, I, the undersigned namely Warepam Hemanta,
aged about 50 years, resident of Old Bazar, Rainkai Road, Sugnu
Bus parking beg to submit the following few lines for your kind consideration
and necessary action.

That on 4th May 2023 at about 1:40 a.m., some unknown persons
numbering about 300 belonging to Kuki Community started attacking the undersigned along
with family members. Thereafter, the Kuki people started destroying and burning the house/Shop of the
undersigned resulting in all the properties of the undersigned were razed to the ground and all the
belongings and jewellerys were also burned/destroyed/stolen.

A separate sheet showing the particulars of all the losses incurred by me is attached along with
the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may
cause the arrest of the miscreants who belongs to the Kuki Community involved in the burning/
dismantling/damaging my properties. So, please take up an FIR against them as soon as possible for
the interest of Justice.
