That on 04/05/2023 at about 11:30 am, some armed unknown persons numbering about 1000 belonging to Kuki community started attacking my family, destroying and burning down all my properties including my Autorickshaw petrol variant bearing registration number MN02 G7867 to ash.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants and take up an FIR against them as soon as possible for the interest of justice.
