Sub:- Request for taking up appropriate legal actions against the persons/ culprits who are involved in the demolition of my house constructed on the piece of homestead land situated at the Thengra Leirak near Chingkonpang, Churachandpur District Manipur according to law.

Sir,

With respectful regards, I, the undersigned beg to submit the following for your kind information and necessary actions :-

1. That, I have constructed my 3(three) storied building at the Thengra Leirak near Cingkonpang, Churachandpur District Manipur on my piece of homestead land recorded in my name. There were as many as 83 nos. of houses belonging to the Meetei/ Meitei community and as many as 355 inhabitants were resided belonging to the Meetei/ Meitei community by constructing their respective houses. My said house was constructed just adjacent to the residence of a Kuki community. (photographs enclosed)

2. That, I beg to submit that since the broke out of the war like situation in the state of Manipur which was erupted in the Churahcandpur, Tegnoupal and Kangpokpi District, Manipur, all the Meetei/ Meitei inhabitants resided at Churachandpur District, Manipur fled away for saving their lives and seeking shelter at the relief camps.

That, it is informed that most of the houses belonging to the Meetei/Meitei community within Churachandpur District, Manipur, have been vandalised within 2-3 days of the eruption of the said incident and the remaining structures have also been demolished by using Excavator, JCB and Bull Dozers. However, my residence was not touched by the Kuki militants/extremist upto the month of July, 2023 by assuming that my resident belong to the Kuki community.

4. That, very recently I came to know that my said residence has been destroyed by the Kuki militants by using Bull Dozer and Excavator etc. and the same have been turned into a ground so that there shall no sign for having such structure. The photograph of the same have been sent by my near and dear friend circles through my phone very recently. I have taken out the photographs of my residence before the same was demolished and after demolition and the same are enclosed herewith for your kind perusal.

5. That, I beg to submit that as the said incident was occurred under the jurisdiction of Churachandpur Police Station. I could not make complain for the same to the Churachandpur Police Station in view of the present ethnic riot. Therefore, my complain is made before your goodself for registration of an FIR so that appropriate legal actions can be taken up against the culprits according to law.

It is, therefore, most respectfully prayed that Your Goodself may pleased to look into the matter personally and take up appropriate legal actions against the culprits at an early date in the interest of justice.
