Subject: Report of damage and destruction of properties by Kuki militants who are presently under suspension of operation with Sir, the government.

With due respect, I, the undersigned namely Shazal Kangabam, aged about 50 years, resident of Khugatampak, Zouvang Zenghang Lamka, CCpur beg to submit the following few lines for your kind consideration and necessary action.

That on 3<sup>rd</sup> May, at about 6pm, some unknown persons numbering about ↓ belonging to Kuki community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelries were also burned/destroyed / stolen before burning/ damage.

In the said incident Kangabam Thaba was badly injured due to pelting of stones/hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/ damaging my properties and injuring Kangabam Thaba and take up an FIR against them as soon as possible for the interest of justice.
