I the undersigned have the honour to state the following lines for favour of kind perusal and necessary action please.

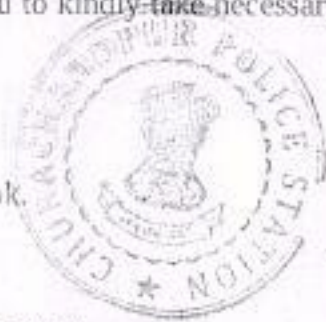
I am serving as Rifleman GD No. AR5009413A and presently posted at 27 Sector, Tuibong, Churachandpur.


