With due Respect, I undersigned namely Maishnam Ibochouba Singh, age about 45 years, resident of Kangmong Mayal Leikai, Nambol, beg to submit the following few lines for your kind consideration and necessary action.

That on 5th May, 2023 around evening, some unknown persons numbering about 40 to 50 persons belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the kuki people started destroying and burning the diagnostic center of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and machines were also destroyed and looted.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki Community involved in damaging my properties and take up an FIR against them as soon as possible for the interest of justice.


