Subject: - Report of damage, destruction of properties and threatening of my family

Sir,

With due respect, I have the honour to state that I am a resident of Ngachoupokpi Khwairakpan village of Bishnupur Dist. and we have been staying at Old Bazar, Churachandpur for about 25 years or so with my family at a rent leased by a local tribesman before the commencement of incident of communal clash in Manipur. But, On 03/5/2023 when the incident broke out, we left the rent house for saving ourselves from them as they threatened to leave the place and took shelter at Meitei Society Hall located at KhugaTampak for the night with other escaped persons from Meitei community.

And, later on, it was learnt on 04/05/2023 morning that their household properties and other important items from the rent house were damaged, stolen and set on fire by a good number of Kuki militants and their supporters who were well armed in the night of date 03/5/2023. Inconvenience while reporting at a later date was due to displacement of house. Presently, we were taking shelter at Okshongbung Relief Camp located at MoirangOkshongbung.

It is, therefore, requested to kindly take a suitable legal action against those miscreants from Kuki communities as per law please.


