That on May 3rd 2023 at about 5:00 p.m. some unknown persons numbering about 100 to 200 belonging to Kuki and Zo community along with the suspected cadres of ITLF, KNA, KNO, ZRA, holding Sophisticated Weapons, started attacking the Meitei Presbyterian Church of India reform (P.C.I) Kutchha building quarter located at Thingkangphal Yalfakol Meitei Leikai, Churachandpur, there after the so called group of people started destroying and burning the Meitei church Kutchha building quarter resulting in all the properties of the church were razed to the ground and all the belongings items were stolen before damages/burning.

In the light of the above facts and circumstance, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Kuki-Zo community involved in burning/dismantling/damaging/looting my properties and take-up FIR against them as soon as possible. In the interest of justice and urge to the concern authorities to compensate for those who expired and damaged all the properties belongs. List of items to be compensated are shown as Annexure.


