Churachandpur, District Churachandpur Manipur would like to report that I, along with my family after leaving our village because of the ongoing communal clash in Manipur, on the 3rd of May 2023 between 10:00 pm to 12:00 am, my residence as mention above at Saiton Khunou was torched and burnt to ash with all our belonging by Meitei miscreant suspected to Amambai Tengol and Meitei Leepun with the help of Police Commando.

The estimated value of property loss in this arson is estimated to be about at the cost of Rs.60,00,000/-(Rupees Sixty Lakhs only) which include of Furniture, Electronic and Household Goods.

Therefore, I would like your request your kind office to take necessary action at the earliest, in spite of my delayed due to frequent shifting of places for which I will remain obliged to you.
