It is therefore, I am requested you to kindly take up necessary legal action against the said Kuki militant and Kuki civilian. I, couldn't report well in time as my wife was admitted at Dispur IVF & Fertility Clinic, Guwahati. So, I could not report well in time due to my highly present is required at the Hospital as well as I have no idea about the law. I, along with my family members presently stay at the relief camp of Ithing, Tourist resort at Sendra Hillock Block-B org. by Youth Development Organization Ithing, Bishnupur District, Manipur.

So, kindly consider my humble request and take action against the unknown miscreants.
