The undersigned beg to report for your kind and necessary action.

1. That I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.
2. That on 3<sup>rd</sup> May 2023 around 6.30 Pm while I was at Dukom along with my family members. Some unknown armed miscreants attacked my Dukom, physically assaulted my family members including myself and destroyed Rs 15,00,000/- approximately.
3. That the unknown miscreants are suspected to be of the Kuki tribes as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my properties. The said unknown armed miscreants also set on fire and burned down my Dukom and other household items which are given in the list enclosed along with this report.
4. Delay of filing FIR complaints is due to the prevailing law and order situation in Manipur.

In view of the facts and Circumstance I shall be very grateful would kindly initiate appropriate steps for identifying the unknown arms miscreants apprehend them and punish them in accordance with law.

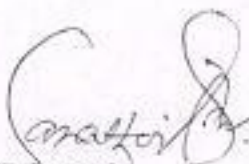
