To, I have the honour to lay the following few lines of your kind consideration and necessary action there of:

1, That on 3rd May 2023 at around 6-30 P.m while I was at my rented Dukkam along with my family members. Some unknown armed miscreants attacked my rented Dukkam, Physically assaulted my family members including myself and destroyed Rs: 22,15,000/- Twenty two lakhs fifteen thousands approximately.

2, That The Unknown miscreants are suspected to be The Kuki dialect while physically assaulting my family and destroying my rented Dukkam and rented house properties. The said unknown armed miscreants also set on fire and burned down my rented Dukkam/house and other household items which are given in the list enclosed along with reports.

3, Delay the filing of FIR complaints is due to prevailing law and order situation in Manipal.
 In view of the facts and Circumstances of I shall be very grateful would kindly initiate appropriate steps for identifying the Unknown arms miscreants apprehend them and punish them in accordance with law.

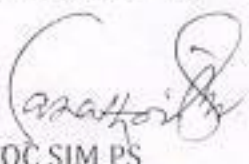
