Sir, I the undersigned beg to report for your kind and necessary action thereof:

1. That I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.
2. That on 3rd May 2023 at around 6:30 p.m while I was at my rented Dukan along with my family members. Some Unknown armed miscreants attacked my rented Dukan, physically assaulted my family members including myself and destroyed Rs 57,00,000 fifty seven lakhs ninety seven thousand approximately.
3. That the Unknown miscreants are suspected to be the Kukis dialect while physically assaulting my family and destroying my rented Dukan/and rented house properties. The said Unknown armed miscreants also set on fire and burned down my rented Dukan/house and other household items which are given in the list enclosed along with this report.
4. Delay of filling FIR complaints is due to the prevailing law and order situation in Manipur.

In view of the facts and circumstances of I shall be very grateful would kindly initiate appropriate steps for identifying the Unknown armed miscreants apprehend them and punish them in accordance with law.

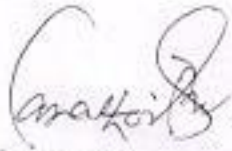
