

few lines of your kind consideration necessary action.

1. That I and my family members are victims of the present
Unrest that occurred from 03-05-2023 onwards.
 2. That on 3rd May 2023 at around 7.30 P.M. while I was at
my rented house along with my family members. Some
Unknown armed miscreants attacked my rented house/
physically assaulted my family members including myself and
destroyed Rs. 59,72,000/- Fifteen lakhs Seventy two thousand
approximately.
 3. That the Unknown miscreants are suspected to be the Kuki
alikest while physically assaulting my family and destroying
my rented Dukan and rented house properties. The said
Unknown armed miscreants also set on fire and burned
down my rented house/dukans and other household items
which are given in the list enclosed alongwith reports.
 4. Delay the filling complaints is due to prevailing law and order
situation in Manipur.
- In view of the facts and circumstances of I shall be very
grateful would kindly initiate appropriate steps for
identifying the Unknown arms miscreants apprehend them and
punish them in accordance with law.




