

I am a businessman and now running a shop of Iron and Steel work at Nehru Marg Junction, Churachandpur. On dated 03/05/2023 around 6:30 pm, a huge number of Kuki-ZO militants with sophisticated weapons started attacking to Meitei community at our village. They burned down all the houses and every household of Meitei till the morning of next day. They threatened us that we have to leave our village otherwise we will be killed. Due to fear and panic, all my family members left home and taking sheltered at 36 AR and sheltering at Relief camp, Mekola Gulap Hr. Sec. School, Mekola. Unfortunately, it is learnt as told by one of my neighbourer who stays just above my shop that all the properties of my shop mentioned in the column no. (4) were damaged and looted and carried away in a DI tata by some unknown persons belonging to kuki community in between the 7 th to 15 th May, 2023. Delay of FIR is due to lack of legal knowledge. After meeting with DLSA-IW, we were advised to register FIR. Please take necessary action against the unknown persons who belonging to kuki community.
