Sir,

I, the undersigned, was running a private clinic at Henkho road CCPur, as Eden Clinic and Diagnostic Centre. I was staying in a rented room at "Sunny Cottage" I.B. Road, Hiangtam Lamka, opposite Synod Hall CCPur for the last 20 years. The name of the owner is Mr. Jummy Guite, aged about 46 years, S/o (L) Kamkhanthang Guite of Churachandpur.

On 2<sup>nd</sup> May, 2023, I came to my home located at Kangmong Langoljam, Nambol as my son was ailing at home. On 3<sup>rd</sup> May, 2023 communal riot between Meitei and kuki took place and I could not proceed any more to CCPur.

It is learnt as informed by my close friend who is residing at CCPur that all my properties inside the rented room has been looted by some unknown armed youths suspected to be Kuki militants on 20<sup>th</sup> May, 2023. Delay of FIR is due to lack of legal knowledge.

I, therefore, requested you to kindly take necessary legal action against the unknown armed Kuki youths at the earliest.
