Subject:- Report for investigation of my destroyed under construction house
by youths of Kuki Community consisting of Kuki Militants.

Sir,

With due regard and respect, I have the honour to report for your kind
consideration and necessary action.

That, I am the owner and recorded pattadar of the homestead land (under
Construction) under Pata No. 7698 (New), 2381/2387 covered by C.S Dag No. 5373/5377
(B/6680) measuring an area of 0.02 acres situated at Khuga Meitei Christian Leikai, Village
No. 99- Bijang Churachandpur.

That, on 04-05-2023, at about 10.00 am, around one thousand youths of Kuki
Community consisting Kuki Militants holding Guns and other deadly weapon had
trespassed my above-mentioned homestead land with an intention and looted all my
property and also my construction materials i.e. cement and iron rode etc. Moreover, they
destroyed my under-construction plot. On seeing their wild act, we fled away from the said
area to a safe place with an apprehension to hurt us by them by leaving all our properties
destroyed. The estimated cost of my looted and destroyed properties is about Rs.
10,0000/- (Rupees, Ten Lakhs) only. The cause of delaying my report is due the undergoing
medical treatment of my father and the unstable law and order situation in the state.

Therefore, I request you to kindly take necessary action against the miscreants for
their wild act. Thanking you for your kind co-operation.
