



Subject Report for Investigation of burning house, looted properties.

Sir,

With due regards to lay a few line in your kind consideration that I Thoudam Rimseen Singh working as a technician at electronic shop (United Refrigeration & co) located at old bazar light house road F95/28 Churachandpur. Sir, working as a technician my residential address is located at Bijang Khunou, Bijang C.Pur. (A rented house own by Lumanan Mycha Meitei) stay from last 2 years back. On 4<sup>th</sup> May, 2023 around 11:30 am around one thousand youths suspected to be Kuki militants from Kuki community carried guns, ammunitions and other deadly weapons from old Bazar and Tribong Bazar. Many of us were killed and injured, we fled and hide places to save of our lives. On that same day, after we fled and the following days, they looted every piece of <sup>my</sup> property & burnt down garage, stock room (rented room). I can't able to report on the night time due to injury on that day and still night now I am under treatment at Rims.

The following particles may had looted and burnt from my  
scented house:-

- 1) Friday Godbrij (6) Rs 1,20,000
- 2) Washing machine (4) Rs 55,000
- 3) Traditional Drus & Carnal Drus around value Rs 90,000
- 4) Gold chain, Ring, etc value of Rs 4,00,000
- 5) Akmirah (2) Rs 40,000
- 6) Kitchen Items Rs 70,000
- 7) sofa set Rs 1,20,000
- 8) Bicycle Rs 15,000
- 9) TV, Speakers, etc Rs 40,000
- 10) Ceiling Fan, Stand Fan Rs 15,000
- 11) Furniture value of Rs 50,000

Total value of the lost item is Rs 10,65,000


