

Subject :- Report on Looting of house, household items/assets.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, L Chinneiniang Simte aged about 48 years W/o L Paulunthang Simte Belonging to the Simte Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of S Bualjang Village Churachandpur District Manipur. P.O&P.S., Churachandpur.
2. That at about 5:30 pm on the 3rd May 2023, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with a mob numbering about 2000 attacked our neighbouring Village. so in order to save our lives we left behind our house with all our belongings, and in the process some unknown miscreants looted my house including all our household items.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 4,00,000/- (Rupees Four Lakhs) only.
4. Fortunately, we managed to escaped from the criminals that day and after some days we can re-settle back to our looted house at S Bualjang Village Churachandpur .
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled back at The above mentioned place. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
