That on 25<sup>th</sup> Aug. 2023 at about 8.30 pm, some unknown  
persons numbering about 30 belonging to KUKI community started destroying "My TATA  
MOTOR WORKSHOP (HEAVY)" which was located at "HMUIA-VEG" Churachandpur. All the  
properties/equipments were damaged completely and some were stolen including shop registration  
certificate issued by A.D.C. Churachandpur.

A separate sheet showing the particulars of all the losses incurred by me is attached along the present  
application.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause  
the arrest of the miscreants who belongs to the KUKI Community involved in the stolen/ damaging my


