With Due respect, I, the undersigned namely Sarangthem Yaiphaba Mitei aged about 29 years, resident of Gilgal, Seimat, cepur beg to submit the following few lines for your kind consideration and necessary action.

That on 03/05/23, at about 11:15 pm, some unknown persons numbering about 300 belonging to kuki community started attacking the undersigned along with family members. thereafter, the kuki people started destroying and burning the house of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleryes were also burned/destroyed/stolen before burning/damage.

A separate sheet showing the particulars of all the loses incurred by me is attached along with the present application.

In the above facts and circumstances, it is therefore respectfully that your good self may cause the arrest of the miscreant who belongs to the kuki community involved in the burning / dismantling/damaging my properties and injuring Nil and take up an FIR against them as soon as possible for the interest of justice.
