With due respect I would like to state that I and my family
members are victims of the present unrest situation here in Manipur
that occurs from 05-05-2023 onwards.

That on 4th May 2023 at around 11:30 pm while I was
at my residence situated at Khumajambei meitei leikai Churachandpur
P.O (Churachandpur) P.S (Churachandpur Police Station) along with my
family members consisting of myself and other family members, some
unknown armed mercenaries that are suspected to be the Kuki tribe
as they communicated themselves in the Kuki dialect have started
destroying and burning the household properties of the undersigned
to ashes and all the jewellery were taken away before
burning and harassing me and my family members. They destroy
all of my properties which will cost around Rs 8,00,000/-
(Eight lakhs) approximately.

In the above view of the facts statement, I would be
very grateful if you would kindly initiate appropriate
steps for identifying the unknown armed mercenaries Kuki tribe
and punish them in accordance with law.
