



Sir,

I the undersigned request you to kindly investigate the loss/theft of my Godrej Iron Chest measuring 2X3 feet in white colour from my residence at Vaiphei Enclave, Langol (opposite Forest Range Office) on 04/05/2023 by unknown miscreants who ransacked and burnt the top floor and looted most of my belongings including the said Iron Chest during the social chaos.

It may be mentioned that the Iron Chest contained the following items:

1. Original documents (Pattas)
 - (a) Land Ownership documents of Kolhen village, Lungchuang Village and Shingmun Village in Churachandpur District.
 - (b) Land Pattas (Plots) of Red Cross road residence and 04 (four) other separate Pattas of family members in Churachandpur Town Area.
 - (c) Paddy field Patta at Kangvai, Churachandpur.
 - (d) 04 (four) Ingkhol Pattas at Vaiphei Enclave, Langol belonging to me and my relatives.
2. Gold earrings, necklaces and rings. (worth about Rs. 10 lakhs)
3. .32 Revolver bearing License No. 1695/CCP (Gun No. E6243) issued to my husband Shri. T. Manga Vaiphei.

I shall be most grateful for your co-operation in the investigation/recovery of the above items.
